ORDER:

In the reference first read above, the Government have issued orders to collect the following User Charges for under taking inspections of Multi Storied Buildings and Hazardous Premises towards issuance of No Objection Certificate and other Fire Safety Measures.

- 2. In the letter 2nd read above, the Director General, A.P. State Disaster Response and Fire Services, Hyderabad, has stated that the Andhra Pradesh, Private School Association have requested to reduce the above user charges from Rs, 10,000/- to Rs.1,000/- for every five years for the self financed, small budget schools (Ground+2 floor Buildings) for inspections and issuance of Renewal of NOC for occupancy and requested to modify the G.O.Ms.No.71, Home (Pri.A) Department, dated.1-4-2010 with relaxation of rules.
- 3. In the letter 4th read above, the Director General, A.P. State Disaster Response and Fire Services, Hyderabad, has furnished the proposals and recommended for certain modifications in G.O.MS.No.71, dt.01-04-2010 for Sl.No. (4) of para no. (6) to issuance of Renewal of NOCs for Occupancy.
- 4. Government after careful examination of the proposal, hereby modified the orders issued vide G.O.Ms.No.71, Home (Prisons.A) Dept., Dt: 01.04.2010 for Sl.No.(4) of Para No.(6) as follows:
 - i. "50% of the statutory fee paid on built up area during NOC, covered under Rule (15) of A.P. Fire Service Act, 1999 and A.P., Fire & Emergency Operations and Levy of Fee Rules, 2006."
 - ii. "25 % of the statutory fee buildings not covered under Rule (15) of A.P. Fire Service Act, 1999 and A.P., Fire & Emergency Operations and Levy of Fee Rules, 2006."
- 5. The Director General, A.P. State Disaster Response and Fire Services, Hyderabad shall take further necessary action in the matter, accordingly.
